## Volunteers find new career as caddies

When Dick and Donna Palmer volunteered to help at the World Bridge Championships in Albuquerque in 1994, they had no idea they were about to embark on a new career -- traveling all over North America and caddying at NABCs.

"When Dick retired," says Donna, "we started on this second career. You need something to break the monotony of retirement."

"We missed Chicago but we've been to just about every NABC since Albuquerque," adds Dick.

"We just go where Jackie needs us."

Jackie is Caddy Master Jackie Matthews, who met the Palmers in Albuquerque and recruited them as caddies and recorders. "I just send Dick and Donna to do something and it's OK," says Matthews. "I don't have to worry about anything. These two have saved me many times."

The Palmers' first NABC was Phoenix in the Spring of 1995 where they caddied for Matthews -- and where Priscilla Smith talked them into playing in the Intermediate/Newcomer game. After the game, Donna recalls, "I said to Dick that wasn't so bad. We can do this."

They went back to their local club in Albuquerque, took lessons, started out in the 0-20 game "and just worked our way from there," says Donna.

They each now have about 260 points, including all their pigmented points. They'll make Life Master

## Lipscomb-Cappelletti win squeaker in Mixed

Shannon Lipscomb and Mike Cappelletti won a squeaker -- their margin of victory: .62 of a matchpoint -- in the NABC Mixed Pairs.

Lipscomb and Cappelletti tallied 2996.88 matchpoints to 2996.26 for Ann Arndt and Godfrey Chang. This was Chang's second runner-up finish at the tournament -- he placed second in the Silver Ribbon Pairs earlier this week.

Sandra Fraser and Dan Jacob were third with 2929.91 matchpoints. Bernace DeYoung and Alan LeBendig were fourth with a total of 2919.60 matchpoints.

Cappelletti, 33, recently reached the 10,000-masterpoint plateau -- one of a handful of players to reach the milestone at a young age. His previous best NABC finish was second in the Reisinger Board-a-Match Teams in 1991.

Lipscomb is a previous winner of the *Junior Player of the Year* title in the Mini-McKenney contests. Her previous in a NABC finish was second in the Life Master Women's Pairs last year in Orlando.

## Board of Directors actions highlighted

Many of the important actions of the Board of Directors have been highlighted in other articles in this and earlier Daily Bulletins. Here are other actions of interest taken by the Board.

**INSTANT MATCHPOINT** games will be held on Friday evening, June 4, and Saturday afternoon, June 5, to replace the World-Wide Pairs games that were canceled. Point awards will be half red and half black. The sanction fee will be \$10 per table.

**MEMBERSHIP DUES** and fees will be increased as follows on July 1, 1999: Non-Life Master, \$28 to \$30; Junior Member, \$10 to \$12; New Member, \$14 to \$15; Life Master service fee, \$25 to \$27; Household, \$50 to \$54. (Special rates are available for players who wish to sign up for multiple years.) Club table fees will be increased as follows on April 1, 1999: annual sanction, \$10 to \$11; unit games, \$1.00 to \$1.10; club games, \$.50 to \$.60. Fees for ACBL-sponsored games will be increased as follows on April 1, 1999: Grand National Teams, \$1.00 to \$1.25; Instant Matchpoint, \$10 to \$11; Senior-wide Game, \$2 to \$2.25.

## 900 out the window on the opening lead

When we see Hugh Ross come into the Daily Bulletin office, we know we're going to get a good story. And this visit was no exception.

"I threw away 900 points with my opening lead, then I pitched another 770 with my lead to the second trick," he said. Of course we had to see the hand.

As you can see, a black suit lead would debilitate declarer. He would be forced to ruff the second round, and the defense would continue with black cards every time they gained the lead. As a result, declarer could take only his five diamond tricks — down four for minus 1100.

But High thought it might be important to lead a trump, and he cashed his ace. Now the best the defense can do is a one-trick set — plus 200. That's the 900-point loss. It got worse— Hugh continued with his other diamond, and suddenly 3♦ doubled was a make — minus 670. There's the other 870 points.

Quite a man, this Hugh Ross, telling this story on himself.

Charles Coon and Dave Bettes had a smooth auction to the grand slam in a semifinal match in the Sunday-Monday Knockout Teams.

When Coon opened 1♦ and East preempted 2♠, Bettes had no good bid and passed. After West raised and Coon doubled, however, Bettes bid 6♣. Coon raised to the grand and 13 tricks were available on any lead. 6♣ was the contract at the other table and the 13-IMP swing accounted for much of the Coon team's margin of victory.



## Good news and bad news

Mel and Janet Colchamiro had good news and bad news. First the bad news -- a hand that occurred in a Continuous Pairs game.

Janet led the ♠A and switched to the ♦J . . . queen, king. Mel returned a spade to the queen and king, and Janet switched back to diamonds, declarer winning with dummy's ace. He ruffed a diamond and led a club, winning the 7 when Janet played low. He crossed to his ♥A and led another trump, this time winning with the 8. Next came the ♥K and a heart ruff, leaving this interesting position:

When declarer now led a trump to the queen and ace, Mel was in deep, dark trouble. If he threw the ♠9, declarer could ruff the diamond, and Janet could overruff or discard. Either way she was going to win only one trick because declarer's ♠8 would be high. If he pitched the ♥Q, declarer could throw his losing spade on the good ♥10. And if he sluffed the ♦8, declarer could get rid of his losing spade on the ♦7. All roads led to nine tricks for a one-trick set -- minus 100. The Colchamiro's collected very few matchpoints

for this result because they can make 3♠.

Now the good news. It took place in the Tuesday board-a-match game.

Mel won the ♥Q with the king and led the ♠J, losing to the ace. West continued with the ♥J to the ace, and Mel drew the rest of the trumps, pitching clubs from dummy. A club to the ace was followed by a heart ruff, and Mel then began drawing trumps. This was the position as he got ready to cash his last trump:

When Mel led the last spade, West was in trouble. If he pitched the ♥10, dummy's 9 would be good. If he threw the ♦A, Mel's king would be good. And if he sluffed a club, both of dummy's clubs would win. After some thought, West made a wish that partner had the ♦K and pitched the ace. But now Mel cashed the ♦K, and West was in trouble again. No matter what he did, Mel had the rest of the tricks -- making six. West's best move would have been to throw the ♥10 -- that gives declarer only one trick -- making five. But it didn't matter -- the South at the other table made only 10 tricks at spades, so even making five would have won the board.

## Today's sponsors

**Fanny Keel Veiner** — This game is sponsored by Shirley Fitterman in honor of her late mother, Fanny Veiner, who was Gordon Keel's brother (a game was named in Gordon's memory earlier this week). Shirley is a keen competitor and an accomplished LM. She has elegance, sensitivity and terrific enthusiasm.

**Andy Nagy** (by Aidan Ballantyne) — Andy was one of my favorite partners until his sudden death in 1985. He was an incredibly talented card player and a winner. At the time of his death he and his wife, Anne, were successful owners of Vancouver's Haida Bridge Club. Together, they did a fantastic job of bringing new players into the game, which is why Anne has chosen to sponsor an I/N game in her husband's memory.

**Sweetpea and Lola** — This event is named to honor a friendship. Sweetpea and Lola are the Internet on-line names of Betty Jackson and Patti Adams respectively. A few years ago, Betty was a novice bridge player in Qualicum Beach on Vancouver Island. At the time, there were no other beginners in the area. In frustration, she decided to recruit her own partner. Patti was a co-worker, and although she had never played bridge, was an avid card and games player. One afternoon, Betty gave Patti a magazine called *15 Minutes to Brush-up Your Bidding*. That evening, they made their partnership debut at the local duplicate game. This was the start of a beautiful friendship. Today, Patti is Partnership Chairperson of these

1999 NABCs. Patti and Betty had planned on playing together in their event, but unfortunately Betty could not get time off from her job in the Northwest Territories.

**Captain Midnight** (by Brad Bart) — Captain Midnight is my favorite bridge superhero. He doesn't wear a red cape or a big shiny 'M' on his chest, but he does wear a big smile and has a jovial attitude. Tournament bridge is competitive and rewarding, but it isn't usually an atmosphere in which people can talk and joke a lot at the table. Midnight bridge is different.

That's where my friend, Dean Bigioni from Toronto, is at his best as the original Captain Midnight. Picture him with 13 cards in one hand, a beer in the other, and talking up a storm. Not afraid to overbid, underbid or hog the hand, he sometimes helps the opponents by telling them their correct line of defense during the play. Captain Midnight truly puts the fun back into bridge.

**Don Fraser** — Although he passed away a few years ago, Don is fondly remembered as one of Vancouver's true gentlemen of bridge. A fine player in his own right, he was equally respected as a teacher, club director and Unit official. His greatest asset was his unfailing courtesy at the table, especially towards new players. Recognizing his qualities, the Vancouver Unit periodically awards a trophy in his name to the local player who best exemplifies the values that were so important to him.

## Vugraph? Maybe!

The vugraph of the Vanderbilt final is problematical at the moment. It will depend on the tournament attendance today and tomorrow. If the huge crowds continue to flock to the bridge tables, there just won't be any space available for the vugraph show. A final decision will be made sometime tomorrow.

## Squeeze via a finesse

John Wong of Los Angeles brought us an interesting hand. The declarer did not find the correct line of play, but the winning play is quite exciting.

The contract is more than a bit optimistic, but now that you're there, what's your plan?

This is a case of visualization. You need to work out the lie of the cards you need for your contract and then play for it. There are nine top tricks, so it is clear that West has to have the ♠K for you to have a chance. But then there's the blocking problem in diamonds. You need an extra entry to the South hand, and the only extra entry would be the ♥Q. So you have to play East for that card. So this is how the play should go.

Win the ♣Q opening lead with king and cash dummy's diamonds. Next lead a heart and hope. Sure enough, East rises with the king and continues with a club. Cash the rest of your diamonds. Now lead a heart to the queen and come back to the ace. Ten tricks have been played, and declarer has a small spade and the ♣9-5. Dummy has the ♠A-Q-J. On the ♥A West has to make a discard from ♣10 and ♠K-8-7. He can't discard the club -- that would set up declarer's 9 -- so he sluffs a spade. So declarer takes the spade finesse, cashes the ♠A dropping the king, and takes the ♠Q for the slam-going trick.

## Swami, ill from Lille, has Vanderbilt feel

After an exhausting 1-IMP victory by Nickell over Whitman in the final of the 1998 Spingold, Pure Bull, aka the Swami, was herded out of Chicago and boarded an overbooked Titanic II — bound for France - - brimming with American hopes for a Rosenblum World Team Championship.

The World Championships left the Bull with a newfound respect for airline travel and the different pronunciations of the Italian letter "A" as the Italian team of Angelini, Burratti, Lanzarotti, Versace and Lauria defeated Brazil for the Gold Medal. In the quarterfinals Angelini had defeated the last standing survivors of the shipwrecked Americans, Bramley-Lazard, Garner- Weinstein and Casen-Pollock.

Returning from France, the Bull and his newest family addition headed down the I-95 trail to the 1998 Fall NABC, expecting a leisurely week with Mickey and the Peabody Ducks, when the 1999 Reisinger was won four-handed by Shugart-Robson and Forrester-Helgemo. A full Texas Longhorn salute to Rita Shugart, the first woman to win a major U.S. team event since 1957. No Bull, Rita's hard drive, *Il y a premier classe*.

Heading for Vancouver, the Bull was caught redhanded attempting to smuggle in 500 pounds of Grenada Grass. Only the intervention of the famous Toronto Shaky, well-known to Canadian and American custom officials, averted an international incident. Once in with his grass, the Bull's vision of the fabulous Canadian West appeared more beautiful than ever. More importantly, the famous Canadian hospitality hosted by the Bull's good friend, Phil Wood, lived up to its expected level of brilliance.

The Canadian hospitality can't save the players from the bridge laws. Another tournament is marred by a match decided by committee. For those who like controversy, in the memory of the great Hideous Hog, the present bridge laws are guaranteed chaos. For those who hope to decide matches at the table, the present bridge laws are a bitter disappointment.

The 1999 Vanderbilt was marked by the early departure of #2 Schwartz and #13 Kasle who included the gracious French world champions, Chemla and Mari. Now down to the quarterfinal, the Bull puts his Bovine Bones at risk of expulsion under Zero Tolerance:

#1 Brachman v. #8 Jacobs.

Brachman is trying to solve world peace. His new team pounded the #1 Nickell in a brilliant upset as Geoff Hampson and Eric Greco beat their mentors, Jeff Meckstroth and Eric Rodwell. Jacobs had the better Italians, for at least one day, defeating Sosler. This will be a tough match for Brachman's young squad to play after an emotional upset. Jacobs by 18.

#2 Lev v. #7 Robinson.

Lev polished off Hartung, the original # 63 who earlier upset the original #2 Schwartz. In a close, well-played match, the New York money IMP game with a Scottish flavor defeats Robinson by 14.

#3 Wolfson v. #6 Shugart.

Zia buys the *Creme De Cassis* for Rita "Ritz" Shugart, but Helgemo defensively squeezes Chip Martel on the last board for an extra undertrick as Shugart continues her magic. The woman is good for a win by 1.

#4 Baze v. #5 Cayne

In a form match, with Martens now playing with Szymanowski, Captain Tip, Casanova Baze and the other Poles, Baliicki and Zmudzinski, defeat the Berkowitz-Cohen, Mike Passell-Mike Seamon and Chuckles Burger with "Alanc4" Cokin filling in for the President and non-playing Captain, Jimmy Cayne. Baze wins by 4 IMPs.

## New Yorkers aim for Women's Pairs title

Judi Radin and Sylvia Moss, both recent winners of NABC women's events, will team up for a try at the Women's Pairs title.

Radin and Valerie Westheimer won the Women's Pairs at the Spring NABC last year in Reno. Moss and Janice Seamon won the Life Master Women's Pairs at the 1997 Fall NABC in St. Louis.

At stake is the Whitehead Trophy, donated in 1930 by Wilbur C. Whitehead of New York, one of the world's greatest bridge authorities and a member of the team that won the Vanderbilt Cup in 1928, the first year it was in play.

Whitehead (1866-1931) was president of the Simplex Automobile Company, but bridge held such a fascination for him that he retired from business in 1910 to devote his whole life to bridge.

At the time he was living in France, where he wrote his first book, *Royal Spades*. A second book was published in London in 1913. His first book to appear in America was *Whitehead's Convention of Auction Bridge* in 1914.

He was the inventor of many of the outstanding conventions of bidding and play, the quick-trick table of card values, the Whitehead system of requirements for original bids and responses and the Whitehead table of preferential leads. He was instrumental in standardizing procedures in auction bridge and later in contract bridge.

The Women's Pairs was the first national event won by Helen Sobel Smith -- she was Helen White when she and Helen Bonwit won the title in 1934. Smith went on to win again in 1938 and 1939 with Sally Young.

The Women's Pairs was also the first national title for Edith Kemp Freilich, who as Edith Seligman won in 1941, 1942 and 1943 with Mae Rosen. Freilich also won with Sally Young in 1946, Virginia Heckel in 1966, her sister Anne Burnstein in 1979 and Nancy Gruver in 1986.

Kay Rhodes and Margaret Wagar hold the record for consecutive wins in the Women's Pairs -- they won in 1955, 1956, 1957 and 1958.

Sam Lev and his international squad (Michael Polowan, Jaggy Shivdasani, Barnet Shenkin, Ravindra Murthy) disposed of Nicholas Hartung & Co. (Daniel Piro, Eugene Prosnitz and Ira Ewen) by a margin of 195-87. HARTUNG had claimed the #2 seed after knocking off Richard Schwartz' squad on day one.

Steve Robinson (Peter Boyd; Kit Woolsey-Fred Stewart; Michael Becker-Michael Kamil) had a comfortable 109-74 but withstood a big rally by Mitch Dunitz (Jill Meyers; Steve Beatty-Allan Falk; Dick Bruno-Jeff Schuett) and claimed a 127-120 victory.

The match between four-hand teams (Rita Shugart-Andrew Robson; Geir Helgemo-Tony Forrester vs. Tom Carmichael-Joel Wooldridge; Marc Umeno-Jeff Roman) was close for the first half. Shugart led 67-60 at the mid-point but opened up a 100-74 lead after the third session and extended their lead in the last set for a 147-118 win.

In our Vanderbilt loss to Jacobs -- a team that used the unfair practice of playing better than we did -- three defensive problems came up. Not all were solved correctly.

Your opponents bid 1♠-2♠, 4♠ and you lead a diamond. Partner can't read your spot card -- he wins the ♦Q and tries to cash the ♦K. Declarer ruffs and plays the ♣2. Do you duck or win?

If you win the trick, plan your defense.

At the table, West won the ♣A and found his partner with an odd number of clubs. He played a second club and that was all the help Alfredo Versace needed. This was the full deal:

Here's one of our bright spots, as reported by Henry Bethe.

Many years ago Terence Reese named some unusual positions, including one he called a winkle. This is a position where one side has winners to burn but cannot untangle them when the communication suit is played. Jeff Rubens, editor of *The Bridge World*, lived for winkles when he was an active player, and those of us who care for Jeff are always on the lookout for them in play. So here's one for you, Jeff.

Declarer won the opening ♠5 lead with the 9 and led the ♣8 to the 10-king-ace. Barry returned a spade to my king and I exited with the ♥A and another heart to dummy's 10. Alfredo now cashed the ♦A-K, then led the ♣7. Barry won and played a club back which declarer could win in dummy and give me the last trick with the ♥Q or win in hand and eventually concede a spade trick. A winkle. A defensive winkle. Winkles are few and precious, but defensive winkles should be treasured as they are rare indeed.

Back to Rigal's report.

Versace led a heart to partner's queen and Henry ducked. He won the heart continuation and drove out the ♣A. A heart came back and Henry won his king and cashed two clubs. On the third round of clubs, West threw a diamond.

When Henry led the ♦Q from hand and Lauria ducked smoothly, Henry was seduced into repeating the finesse. Lauria won and returned a diamond. When he won the ♠K, he cashed the 13th diamond for down one.

Henry was kicking himself for not realizing that if Versace had the ♦K, he would probably have covered the second diamond. The winning line is to rise with the ♦A on the second round, cash the last club and exit with a diamond, endplaying East to lead a spade away from his king at trick 12.

**MANAGEMENT IS AUTHORIZED** to establish the price of all ACBL products and services with the exception of sanction fees, membership fees, Life Master service fees and tournament director fees.

**A CODE FOR SERVICE** and conduct standards for tournament directors will be established and these standards and procedures will be published. A mechanism for reporting violations will be developed. Effective as of the Summer 1999 NABC.

**AN ACBL VICE PRESIDENT** will be elected annually as provided for in the ACBL Bylaws.

**THIS MISSION STATEMENT** was adopted: "The mission of the ACBL is to serve the bridge-related interests of its members and to promote and sustain the game of bridge."

**TRAVEL AGENTS** in addition to the "official ACBL travel agent" shall be permitted to distribute brochures at NABCs. Management shall request bids for a housing bureau service from alternate vendors as soon as feasible.

**THE ROOM RATE** for the 1999 Fall NABC at the Westin Hotel in Boston will remain at the corrected price of \$101.

**ALTERNATIVE SITES** for the 2001 Summer NABC and for future NABCs in Toronto will be explored. Management will report if necessary and appropriate to the Executive Committee.

**AN APPEALS ADMINISTRATOR** shall be appointed annually by the president subject to the approval of the Board of Directors. The Administrator will have responsibility of working with the Chief Tournament Director to compile an Appeals Casebook. The book shall contain selected cases from the three NABCs and any other significant cases from other events. The Administrator will be on-site for each NABC. If unable to attend, the Administrator will be replaced by a substitute appointed by the president. The Administrator will work with the Daily Bulletin and the Chief Tournament Director to produce write-ups of the results of bridge appeals committees including those heard by the Player committees and Tournament Director committees. Appeals in the book will include those heard by both types of committee.

**THE DIRECTOR OF NABC APPEALS** shall, in consultation with League Counsel and the National Recorder, determine whether on-line bridge services which seek to award ACBL masterpoints are in compliance with ACBL regulations in ACBL-sanctioned events regarding on-line ethics violations, investigations thereof, and reporting same to the National Recorder.

**A FULL WEEK** will be designated for both of the Continent-wide Charity Games and for both of the International Fund Games. One session during the week will be designated as a hand-record-with-analysis session, the date to be determined by ACBL management. This session will determine overall winners for publicity purposes. Each sanctioned club will be allowed to hold one such game during each of these weeks. On the hand-record day, the donation to the Charity Foundation or to the International Fund will be \$1.50 per person. On all other days the donation will be \$1.

**MASTERPOINTS MAY BE AWARDED** for games held by online bridge clubs. Fees will be \$11 per year, \$1 per game and \$.60 per table.

**WINNERS OF THE WBF SENIOR Pairs**, WBF World Swiss Teams, WBF World Mixed Teams and WBF Senior Teams will be eligible for Grand Life Master status as long as all other conditions are met. Such victories will be sufficient to fulfill the requirement that Grand Life Masters must win a North American championship.

**THE GRAND NATIONAL TEAMS** Flight A masterpoints won at the NABC final in the semifinals and finals will be included in the Player of the Year race. They also will be included for the Fishbein Trophy awarded to the player winning the most masterpoints at the Summer NABC.

## Second time's the charm

Two Vancouver women -- playing together for only the second time -- posted scores of 60.61% and 57.39% -- to win the NABC 49er Pairs and the Fifth Chair Trophy.

Linda C. Bell and Kristina Bohdanowicz won by 18 points -- top on a board was 11 -- over David Hooey of Port Moody BC and Kas Dykstra of Burnaby BC. The winners' total score was 311.50 to 293.60 for the runners-up.

Completing the all-BC sweep was the third-place pair: Dorothy Whittome of Duncan and Ruby Krause of Ladysmith, who totaled 291.77 matchpoints.

Bell and Bohdanowicz were presented the Fifth Chair Trophy by Marcia West, Fifth Chair president, and David Silber, ACBL's chief executive officer.

Bell has been playing about two years and Bohdanowicz about three years. They got together because Bell's regular partner has 55 points and was ineligible for this event, limited to players with 0-50 masterpoints.

Bell and Bohdanowicz have about 25 points each.

23 years and I'm really going to miss her."

John Ashton, assistant director in charge of this tournament, is another Kipperman fan. "I call her a tireless worker who is always in a good humor. She looks after her job and she looks after your job -- but not intrusively."

Kipperman began playing at her local club in the early Sixties. "I was the only one who knew how to add so I always did the recap sheet," she recalls.

Within a few years, she was working at sectionals as an assistant to the late Bob Dischner. She worked her first NABC in Coronado in 1968. "There's a lot more paperwork involved now," says Kipperman. "We used to score our sheet, do a press sheet and we were finished."

"We used to have great fun when we scored by hand. It took longer but it was a more social atmosphere for the directors."

In those days, women directors didn't work the floor or make rulings but were assigned scoring duties. "She's lived through all these changes -- from hand scoring to computers," says Tom Whitesides, NABC chief finance officer. "She was in her late sixties when she was promoted to Associate National Director. She is a truly remarkable woman and we are going to miss her."

As an Associate National Director, Kipperman ran all the regional tournaments in Districts 22 and 23 and most of the regionals in District 17. In 1993, she and Whitesides became the finance officers for the NABCs. "It's different," she says. "I'm not on my feet as much but the hours are long."

The hours were also long when she worked with Phil Wood, honorary chairman of this tournament and retired National Tournament Director. Wood recalls that Kipperman -- he calls her "the littlest giant" -- ran his office at the Penticton BC regional for six consecutive tournaments.

Penticton is one of Canada's largest regionals but "she didn't just sit in the office," says Wood. "On a scale of one to 10, I give her a 10 1/2."

Kipperman also draws rave reviews from Betty Bratcher, director in charge of the Intermediate/Newcomer program at the NABCs. "We're from the same area and I've worked with Ellie since I've been a tournament director. I think I'm a better TD as a result of working with her."

Bratcher recalls an occasion when she was running the district NAOP finals -- with flight B at a separate location. The director who was to run the event called in sick about 6 a.m. and Bratcher called Kipperman. "All she said was, 'Of course, I'll be there -- what time and where?'"

Kipperman says she'll miss the NABCs but "I still play all the time in my own little club game in Coronado -- two or three times a week. I expect to play more now."

## A crucial deal

Last year in Reno I was standing around waiting for something good to happen when Grant Baze came over to ask whether I was available to play in the Charity Knockouts. I said yes and something good happened — we went on to win the event. This year, when Grant asked again whether I was available, I again said yes. Our teammates were different but the result was the same. I of course immediately suggested to Grant that we make a date now for Cincinnati.

One of the hands sticks in my memory because I think it is a very interesting bidding problem, and it was crucial to one of our early round victories.

By far the best contract on these hands is 6NT -- about 90% I think. Even 7NT, which I make to have about a 55% chance of coming home, is better than a small slam in any particular suit. Fortunately for us, spades were 3-3, so 6♠ made easily. After a singleton heart lead, declarer in 6♣ bollixed up his entries to go down several.
