# Shugart well ahead in Open BAM Teams

The captain of the team leading the Open Boarda-Match Teams is none other than Rita Shugart, one of the women featured in the article about the surge of women in open events elsewhere on this page. Shugart's team, which is the defending champion, consists of Andrew Robson, Tony Forrester and Geir Helgemo.

Shugart's team had two fine sessions -20 and 17.5 - for a total of 37.5, good enough for a 3.5 board lead over three teams tied for second: teams captained by Grant Baze, Mark Bartusek and Farid Assemi.

# All-Texas team leads Women's BAM Teams

The all-Texas team that has already won two major women's events in 2000 -- the World Women's Bridge Olympiad and the Women's International Team Trials -- has a two-board lead going into today's final two sessions of the Women's Board-a-Match Teams. Petra Hamman, Peggy Sutherlin, Joan Jackson, Robin Klar, Shawn Quinn and Mildred Breed scored 35.50 to head all qualifiers.

In a game dominated for decades by men, something strange is going on in high-level bridge these days. Women are entering -- and winning -- more and more open events.

You want evidence? How about these facts? In the last couple of years:

• Rita Shugart, playing four-handed, has won the Reisinger Board-a-Match Teams twice and the Open Board-a-Match Teams once. Shugart will be trying for her third straight Reisinger win here at the Fall NABC, and she's leading the Open BAM Teams.

• Rose Meltzer has won the 2000 Spingold Knockout Teams and the 2000 World Transnational Open Teams. Meltzer is the first woman to win the Spingold since Edith Freilich did it in 1963. Meltzer and her team also finished second in the Open Swiss Teams at the Spring NABC in Cincinnati, advanced to the semifinal round at this year's International Team Trials and were runners-up in the Flight A Grand National Teams at the Summer NABC in Anaheim.


• Jill Meyers won her first major open championship (the Edgar Kaplan Blue Ribbon Pairs, with John Mohan), only the second time in the history of the event that a woman finished in first place. Meyers added a second major open championship here in Birmingham: the Life Master Open Pairs with firsttime partner Steve Garner.

• JoAnna Stansby won her first North American championship in an open event — the four-session Life Master Open Pairs, with husband Lew.

# Norman Kay named Honorary Member

Norman Kay, one of bridge's all-time greats and a member of the ACBL Hall of Fame, was "flattered and surprised" when he learned that he had been designated the 2001 ACBL Honorary Member by the ACBL Board of Directors. "I don't think I'm all that worthy, but I'm pleased," he said.

Not all that worthy? First of all, Kay is a gentleman – a man admired and well-liked by everyone. He is a champion player – the ACBL *Bridge Bulletin* named him the #1 player for the 20-year span from 1957-1977. Although he never has won a world championship, he has finished second in two Bermuda Bowls and one World Team Olympiad. He has been an able administrator, serving as president of the Keystone Conference and working with the Philadelphia Contract Bridge Association for 30 years. He is co-author of *The Complete Book of Duplicate Bridge*. Such achievements make him more than worthy

# Attack, the best form of defense

East has a problem in the auction. Should he open 3NT? If he opens  $1 \blacklozenge$  and hears his partner respond  $1 \bigstar$ , what should he do now? In practice, all roads led to the notrump game and the play is very interesting there. It was common for South to lead a club. Should declarer finesse or not? At our table, declarer finessed the jack (falsecarding with the  $\clubsuit$ 9) and played the A-K and a third diamond. What is North to discard? The winning defense is for North to discard both his clubs, clarifying the count in that suit. This lets South work out to exit with a high club, forcing declarer to cash the club winners in dummy. That brings declarer up to 10 tricks but forces him to make a discard which I guess should be a spade. Now should he finesse in hearts and try for the earth? I think not—best is to lead the ♥J from dummy to test North. When he ducks smoothly, one might as well settle for plus 630 and what actually turns out to be a very poor score. Why is that? Several defenders cashed the A at trick five to let through 660 – but even worse was for South to exit with a low heart or spade. Now South is triple-squeezed on the run of the diamonds for minus 690.

# Matchpoint madness

Steve Garner and Jill Meyers are longtime friends, but they had never played bridge together until Friday and Saturday's Life Master Open Pairs. They had a slender lead going into the final two sessions and won the event by 1 1/4 boards.

Garner is an options trader in Chicago. Meyers has won three world championships, nine North American championships – plus the Transnational Mixed Teams at the recent Olympiad in Maastricht, Netherlands.

On this deal from the second qualifying session, Garner knew the pair had a 5–3 spade fit but he made a "matchpoint madness" decision to try for a notrump game.

At IMPs, said Garner, he would have bid 4 directly over Meyers' preference to 2NT, but at matchpoints he opted to suggest notrump. Meyers, with an almost self-sufficient club suit, raised to the notrump game.

East led the  $\clubsuit$ 9, Garner put in dummy's queen and West -- not wanting to set up dummy's long suit -- ducked. Garner led a low spade to his king and East played the  $\bigstar$ 10.

Hoping to smother a doubleton  $\bigstar J$  10, Garner led the  $\bigstar Q$  and East won his ace. He exited with a low heart to dummy's queen and West's king. West returned a heart and Garner won in dummy. He drove out East's  $\bigstar J$  and claimed 10 tricks for plus 430 and most of the matchpoints.

Playing 4, Garner would lose two spades and a heart and score only 420.

Garner and Meyers got to 6♣ on another deal and Garner kidded Meyers about her pre-game remark: "You can take my two-level overcalls to the bank."

"I was trading on the vulnerability," countered Meyers.

Ernie knew there was a strong possibility that his partner held one of the major suit queens since she was supposed to have at least 5 HCP. However, the fifth point could have been the  $\bigstar J$ , and then he would have to decide which major-suit finesse to take.  $6 \blacklozenge$  looked a lot safer, and he was reasonably sure that players in this event using standard methods probably would fail to find the slam.

He was right – the Fuscos got a next-to-top when all but one of the rest of the pairs played in 3NT – one got to 6NT for the top. That good board, earned late in the event, helped them to go on to victory in the Non-Life Master Pairs. East opened 1♦ and Meyers overcalled 2♣. West passed and Garner, remembering the "take 'em to the bank" promise, decided to suppress his six-card heart suit and drive to the club slam.

A trump lead would have beaten the ambitious contract but East, hoping his partner had either the  $\blacktriangleleft A$  or the  $\bigstar A$ , led his singleton  $\forall 3$ .

Meyers won dummy's ace, played the  $\blacklozenge$ J to her ace, ruffed a diamond and cashed the  $\blacklozenge$ A K, pitching a heart. She ruffed a spade, ruffed her last diamond with dummy's  $\clubsuit$ A and ruffed a spade back to her hand. She drew trumps and conceded a heart for plus 920 – and all the matchpoints.


# A three-story board

Clearly you can make  $6 \blacklozenge$ , 6NT and  $7 \blacklozenge$  on this board from the second qualifying session of the Life Master Open Pairs. Just read on to see how.

The first report is from Barry Rigal, who points out that the true expert would rather play for a squeeze than take a finesse. And of course he's right.

Jeff Blond reached  $6 \blacklozenge$  as West and North was endplayed on opening lead. The  $\bigstar 2$  lead gave declarer a trick after which he misguessed diamonds. After cashing the  $\bigstar A$  K to pitch hearts, he ruffed out his last heart and exited with a diamond. South won and returned a heart in this position, offering a ruff and discard:



Blond now had a choice of plays -- the simple club finesse being the easiest – but no expert would do that! He pitched a club to ruff in dummy, then crossed to the  $\clubsuit$ K and led his last trump to squeeze North in the black suits.

The next example also is from Rigal. Gerry Gittles, playing with Joe Machotka, was in 6NT, reached after Puppet Stayman and a bidding misunderstanding.

Again with West declarer, North is under real pressure on opening lead. His choice of a diamond allowed declarer to play off three rounds of the suit ending in dummy. Now came a club to the jack and queen, endplaying North again. This time, however, a club exit did not really give up anything. Gerry was in hand and could take the spade finesse for the contract.

But the opening lead had strongly suggested North had a problem; so declarer cashed the  $\forall A$  and ran the minor suit winners to squeeze North (this time in the majors) for 12 tricks and a clear top.

John Swanson came by and told us what happened at his table. He and his partner got to  $6 \blacklozenge$  on this auction:

played the ace, king and another spade. That ruffed out the queen because North had had to discard twice on the diamonds.

"Richard then told me he played *low* when he got a heart opening lead, so the jack forced the ace. He told me he played for 2-2 diamonds, so he was one down.

"I then confessed. I told him I too played low on the heart opening lead. But South had an aberration and played the  $\P9$ ! I won the 10 gratefully, of course, and the rest of the play went as I described.

"It's a great example of how you get good scores."

# Entry – what entry?

Board 10 of the first final of the Life Master Open Pairs offered a perverse example of the idea that nothing in bridge is ever obvious.

Consider the club suit on this deal: with the  $\clubsuit Q$  onside, it should be easy to get to the South hand to finesse in spades, right? Not so fast. I reached  $2 \clubsuit$  from the North seat after this auction:

East cashed the  $\bigvee A$  K and led a third heart, ruffed and overruffed. East's failure to shift to a club suggested she held the queen, so it looked normal to play the suit – but which card?

I actually led a low club to the jack and ace. I won the diamond return and led the  $\clubsuit 10$  from hand – but East ducked and now I could not reach dummy to take the spade finesse.

The same logic applies if I lead the  $\bigstar$ 10 from hand initially. Both defenders duck and I never reach the board. In consequence, the defense gets to score three trump tricks eventually and that means one down.

orary Member title with the late Jane Johnson, the able ACBL administrator who died at this tournament.

Probably the name of Edgar Kaplan pops into the minds of modern players when they hear the name Norman Kay. Kay and Kaplan, a close-knit partnership for 30 years until Kaplan's death, instilled fear in the hearts of all opponents, so formidable were they as a pair. Kaplan called it when he once said, "The only thing that will even take us apart will be death."

"Edgar and I were like brothers," said Kay.

But what modern players don't know is that he had another long-term partnership. He and Sidney Silodor were a powerful partnership for five years – this liaison ended when Silodor died.

Kay is here in Birmingham, but he's not playing. "I don't play bridge any more – well, occasionally with Eddie Kantar, but he's not coming to this tournament." Kay has been on the sidelines ever since Kaplan died.

"Edgar always made sure I got full information," said Kay. "He often knew more about the opponents' systems than they did. He protected me from those I needed protection from."

Kay learned bridge in 20 minutes! Well, sort of. A friend, Burrell Humphreys, was hosting a bridge game when suddenly one of the players couldn't come. The friend called Norman and asked him to come over and play. Norman told him he didn't know the first thing about the game. "Well," said his friend, "come over right away. I'll have 20 minutes to teach you the game before we start."

Does the name Burrell Humphreys ring a bell? On the way to becoming a retired judge, he was a Life Master, a lawyer, a prosecutor, a judge and a senior judge. He was the prosecutor in the famous Hurricane case.

After "learning the game in 20 minutes," Kay moved up the ladder steadily. Eventually he won 28 North American championships, and he represented the United States and North America many times in world events.

When Kay was working his way up the ladder, he played on a good Philadelphia team that won its share of events. This came to the attention of B.Jay Becker, and an arrangement was made for Kay to play with Becker so that Becker could assess his game. "I played extremely well – better than I thought I could," said Kay. "B. Jay told me he was going to study our game and let me know where I stood. Finally he let me know that I had a bright future but that I wasn't ready for the top level yet."

Bridge certainly has not been the only major interest in Kay's life. He retired from Merrill Lynch in 1988 after 38 years in a job he really enjoyed. He also owned and races harness horses from 1980 to 1987. But the subject that really got his attention – and his wife Judy's – was baseball cards.

He got into baseball cards through the back door. His son Larry started a baseball card business but soon tired of it. A fairly large inventory had been built up, so Norman and Judy decided to take over the business. Kay can keep you entranced for hours telling about his dealings with the likes of Ted Williams, Warren Spahn, Bob Feller, Pete Rose, Stan Musial and Joe DiMaggio. He believes Brooks Robinson, star third baseman for the Baltimore Orioles, was the friendliest to the kids who showed up at autographbaseball card shows. Larry never took an interest in bridge, but Judy has been a regular at tournaments for many years. Their daughter Robin also is an avid bridge player. It seems strange to see Kay at a tournament where he is not a player. But once again he is helping out in his own special way.

"I was talking to Richard Zeckhauser after the session," said Swanson, "and he asked me what I did on Board 4. I told him I was in 6♦ making seven. He wasn't too happy about that as he told me he had played in 6♦ making five. I chuckled as I told him I guessed I had played the hand two tricks better than he did.

"I got a low heart lead that I won by putting up the queen. I played to the  $\P A$ , went to the trump king and ruffed the last heart. Then I crossed to the  $\clubsuit A$ and ran the  $\blacklozenge J$ , a move that insured the contract – North would have been endplayed in all three suits if he had the  $\blacklozenge Q$ .

"When the jack held, I took the other trump and

Is this an unprecedented development — or an anomaly of some kind? And what about the fact that the teammates and partners of these successful women are of the opposite sex? Does that detract from their accomplishments?

No, says former world champion Peter Weichsel, a member of the Meltzer team. "There's no reason why women shouldn't do well at bridge. They are certainly putting more effort into it now. Rose and Rita are both incredibly intense, willing to dedicate themselves in that attempt."

Throughout bridge history, women have had limited success in the big three – Vanderbilt, Spingold and Reisinger. In the 72-year history of the Vanderbilt, only six women have won the trophy. In the 70-year history of the Spingold, only 10 women have been winners.

For some reason, women have done much better in the Reisinger: in 70 years of competition, 24 women have claimed the title. This includes the 1947 event where an all-women's team – Sally Young, Kay Rhodes, Jane Jaeger and Paula Ribner – finished in a three-way tie for first, the only all-women's team to win a major open event.

Helen Sobel and Freilich are the only women who have won all three – Sobel won the Vanderbilt in 1944 and 1945, the Spingold in 1944, 1947, 1951, 1956 and 1960 and the Reisinger in 1941, 1943, 1950 and 1957. Freilich won the Vanderbilt in 1963, the Spingold in 1963 and the Reisinger in 1946 and 1952.

This brings us to Birmingham and the 2000 Fall NABC – where Shugart and her team are the defending champions in the Open Board-a-Match Teams and two-time defending champions in the Reisinger Board-a-Match Teams and where Meltzer and her team will try to continue their brilliant run in 2000.

"We're going to go and have a great time and, hopefully, we'll win," Shugart said just before the NABC began. "You might play well but you have to have an element of luck to win.

"Nobody can win all the time but if you can't win, you want your friends to win. I was truly delighted for Rose (in Anaheim) – I'm dreadfully proud of her."

The two have been friends since they met playing duplicate in the late Seventies when both lived in New York state. "We played together a few times," recalls Meltzer, "and I kept a close watch on her bridge career."

Shugart was born in Yonkers NY and was educated at Good Counsel College in White Plains NY. She married Alan Shugart in 1978 and, along with her three daughters, moved to California in 1980.

She and Alan played a little bridge when they were first married "but we decided it was best for the marriage if we didn't play together."

She owns three women's and two children's clothing stores in Southern California. Her daughters run the stores now and Shugart says, "I do stocks in the mornings and paint in the afternoons -- mostly oils."

Meltzer also grew up in New York state and learned 22.49 play bridge in college: Columbia University and 16.87 Julliard. She is the mother of "two of the most gorgeous sons you have ever seen." She and her brothers manage 12.65 a family-owned real estate company in Manhattan. She married Cliff Meltzer in 1990 and moved to 9.49 California in 1997. Shugart was delighted. "I get to see Rose a whole lot more often, which is nice," she said. 7.12 Shugart introduced Meltzer to Kyle Larsen and Peter Weichsel and "I decided to take the plunge (into 7.00 open competition)," says Meltzer whose first North 4.00American win was the 1998 Women's Swiss Teams. A major factor in her decision: the support of-5.25 fered by Shugart, husband Cliff and women's events partner Jo Morse. 2.50 Meltzer's success hasn't surprised Morse. "Rose and Kyle are not a weak link," she says. "They are a 3.94 tough partnership, and I'm not just saying this because she's my dearest friend." 2.95 On the road to the Spingold win, the Meltzer and Shugart squads met in the quarterfinal round with 2.21 Meltzer prevailing 124-119. Both women laughed

about people who asked if they were still speaking.

"Rita was the first one who hugged me, who sent me flowers and champagne," says Meltzer. "We are very good friends and we're thrilled with what's been going on."

As for the Spingold win, she adds, "I am still flying so high. I have the world's best team. They have always been so supportive."

Shugart has the same assessment of her team. "It's nice to like the people that you play with. Ninety to ninety-five percent of the battle is having a great partner – and great teammates. I'm extremely delighted with my team."

The squad usually gets together after the evening session to discuss boards. "We're not assessing blame," Shugart emphasizes. "None of the four of us has ever said, 'How could you make a bid like that?'

"Occasionally, one of us will say, 'We're not discussing this one' and we go on to the next board."

Of her two Reisinger wins, Shugart comments, "I didn't think lightning could strike twice."

The final session started slowly, she recalls. "All of a sudden, Board 13 came along and it went win-win-win."

Robson, Shugart adds, "is probably the best teacher I've ever had."

Among his lessons: "It's sometimes what the opponents don't bid that tells you as much as what they do bid."

For her part, Meltzer credits Weichsel, "my mentor and teacher. He has really helped my game."

Weichsel, who plays with Meltzer regularly in pair games (they recently won the North American Open Pairs Flight A in District 21) and as a regular teammate, says she has worked hard for her success. "I think there was only one match (in the Spingold)

where she and Kyle had a bad set. The rest of the time we were ahead. Rose should feel very proud of her accomplishments in our Spingold win."

Shugart also gives credit to the late Bobby Goldman, one of her first teachers and partners. "He told me that you can be a winner or you can be a good player. I want to be a good player. I've always aimed for the top. I've always wanted to play against the best."

The Shugart squad has played four-handed since the 1998 Spring NABC – "it's been great" – and Shugart is now trying to convince Meltzer to follow her example.

Meltzer is quite satisfied to play with six, explaining, "Rita has more stamina."

In fact, Shugart's stamina is legendary. "We finish playing 11 days at an NABC," she says, "and my teammates say I could play another two weeks – and they're right.

"The things you do in life you have to love," adds Shugart.

Among the loves of her life are her three daughters. "I'm proud to say they're not only my daughters but my friends. They love the fact that I play bridge and they're very proud of me."

What's next? Both are planning further treks to the 2001 NABCs and Meltzer is also heading for the 2001 World Bridge Championships in Bali and the 2001 ITT.

"I think that as time goes on, you're going to see a lot more women in the open events," says Meltzer, who singles out the team captained by Lou Ann O'Rourke (Billy Miller, Curtis Cheek, Ron Smith, Roger Bates) as the next candidate for big wins. "As Rita says, you know there's no reason why women can't compete in open events. I consider myself one of the luckiest people in the world."
