"Spider" Harris stories are as colorful as the man himself

Today is John "Spider" Harris day, honoring one of the best-loved, most colorful tournament directors ever to make a ruling or sell an entry. Harris died nearly eight years ago in a Houston hospital of liver failure and pancreatitis. He was 63 and was two years into retirement after more than 30 years as a TD.

As you can imagine, Spider Harris stories are plentiful — many of them even printable.

Born in Pecos TX and raised in Mississippi, Harris earned a degree in math from the University of Houston and a degree in physics from Rice Univer-

sity. He had a life-long romance with the English language and had little tolerance for those who misused or abused it.

His talent for selecting accurate words to express precisely what he wanted to say and his logical and intelligent thought processes gave clarity and accuracy to his writing. This was noted in many "Ruling the Game" articles he wrote for *The Bridge Bulletin* in the years before his retirement.

The first story relates to Spider's insistence on the proper use of English.

Make sure you have 2 convention cards!

Each player is required to have a convention card legibly filled out and on the table throughout the session. Both cards of a partnership must be identical and include the first and last names of each member of the partnership.

If a director determines that neither player has a substantially completed card, the partnership may play only Class A conventions and may use only standard carding. This restriction may be lifted only at the beginning of a subsequent round after convention cards have been properly prepared and approved by the director. Further, the partnership will receive a $1/6^{th}$ -board matchpoint penalty for each board played, commencing with the next round and continuing until the restriction is lifted. In IMP team games penalties shall be at the discretion of the director.

If the director determines the partnership has at least one substantially completed convention card but has not fully complied with ACBL regulations, then the director may give warnings or assign such penalties as he deems to be appropriate under the circumstances.

The objective of these warnings and penalties is the encouragement of full compliance with ACBL regulations.

JoAnna and Lew Stansby

Stansbys surge to victory in NAOP-A


"I would have gladly settled for second when we sat down for the final session," said many-time world champion Lew Stansby. But he wouldn't have settled for second as he and his wife JoAnna took their places for the last round of Flight A of the North American Pairs. They were far enough ahead that they could cinch the championship with an average last round.

They had the average round they needed and more to wind up as winners of this event for the first time. They finished with a powerful 71% for the session to outdistance runners-up Joseph Godefrin and Ed Schulte by a board and a half. Mike Polowan and Adam Wildavsky, leaders going into the final session, were third, only a point and a half behind second.

"This is the tenth time we have played in this event, and we've been among the leaders several times," said JoAnna. "But this is the first time we've won."

It's the third North American victory for the Stansbys as a partnership. They won an Open Pairs event and their team took the Mixed Teams crown in Toronto last summer.

Unlike many North American champions, neither Lew nor JoAnna makes a living from the game. Lew dabbles in commondities trading and JoAnna is a pharmacist. They play a system that is akin to Kaplan-Sheinwold, complete with weak notrumps



Cohen was impressed with Leicht's demeanor. "She was very composed, especially considering that her plane was so late," he said.





Put on the pressure!

Lyle Poe found a nice play to make his slam on this deal from the second qualifying session of the North American Open Pairs.



On the spade lead Poe took dummy's ace and immediately led a low heart. Be honest – would you have been able to duck this as North? North took his king and played back a spade, but the damage had been done. Poe ruffed the spade, drew two rounds of trumps with the king and queen, then led the ♥J to the queen and ace. Next he passed the ♥9 when North ducked. He ruffed the next heart, drew the last trump with the ace and cashed the 13th heart. Then he took the club finesse for his contract and 23.5 of the possible 25 matchpoints.





and a two-over-one game approach.

They found their way to a fine slam on Board 23 of the final session.



2♣ was a forcing raise, and 2NT showed a nonslammish hand with points for a strong notrump and probably only three clubs. 3♥ showed shortness and both 4♦ and 4♠ were cuebids. Lew's 4NT bid offered JoAnna a choice – pass or 6♣. Opposite good clubs and short hearts, she went for the slam and earned a fine matchpoint result.

No cover? They don't have it

He won the opening heart lead with the jack and immediately led the $\clubsuit J$ — which he felt sure East would find himself unable to resist covering. Naturally East played low, so Stansby went up with the ace, cashed the $\spadesuit A$ and overtook the $\spadesuit J$ with the ace. He cashed the $\spadesuit K$ and led his second diamond, uttering a small prayer as he finessed the jack. When the suit behaved he had his 10 tricks and a fine score since 11 tricks were the limit in either clubs or diamonds. Lew collected 23 of the 25 matchpoints available for his effort.



It was widely known that one way to get Harris' dander up was to refer to "chicken fajitas." A fajita, for purists, is a flank steak, and Harris objected greatly to assigning the term fajita to anything but part of a cow.

"Chicken fajitas!" he would say scornfully. "There's no such thing! Chickens don't have hips!"

At a Houston regional, a troublemaker who was aware of Harris' notions about chicken fajitas approached another director within earshot of Harris and asked, "Say, do you know where I can find some good chicken fajitas?"

A third director started to speak up and give directions to a restaurant, but Harris only furrowed his brow and said, "Who told you about that?"

Because he was almost never in competition in the 30 years before his death, most people did not know that Harris was an excellent bridge player. He was national intercollegiate champion in 1952. He won several regionals and became a Life Master before he became a director.

Harris honed his skills at the famous Bobby Nail rubber bridge club in Houston. One time at Nail's, Harris was playing with a man who, to put it kindly, was confused. On defense against a suit contract, Harris' partner led the king of a plain suit. Harris played the 7. Next came the ace of the suit. Harris played the 2.

The man scratched his head and worried over his next play for minutes before finally switching to another suit. Harris did not get his ruff.

In the aftermath of the misdefense, Harris asked why the man had switched after Harris had played high-low to indicate a doubleton.

"I knew you played low the second time, but I couldn't remember what you played the first time," the man said.

"But," sputtered Harris, "I played the TWO the second time! Playing with you is like. . . "

Well, this *is* a family publication.

A tournament director from 1961, Harris was a national tournament director from 1972 until his retirement 20 years later. At his retirement party at the Orlando Fall NABC, Harris said that his immediate plans were to finish work on his sailboat and sail "all over the world." Work on the boat finished, his first stop was to have been the Cancun MX regional that June.

In the Seventies he came up with a plan to provide accurate scoring for difficult numbers of tables for pairs events at smaller tournaments. Harris' movement accommodated any even number of tables from 14 through 20, with all pairs playing the same boards.

At the same time, it eliminated the universally disliked twinned three-quarter movements with combined matchpointing. The Web Movement, as it was called because of his nickname, was devised, he said, "as an idle exercise that happened to work out."

His friends and co-workers remember many of those idle-moment exercises when Harris, pencil in hand and brain in gear, worked on some knotty tournament problem or unearthed the precise meaning of a certain bridge law and how it was meant to be applied. He was able to get around the extraneous and get to the meat of a problem or a paragraph.

Many, many after-game, after-tournament hours were spent in the company of other bridge directors, testing and probing and playing games – word games, charades and games like Go, chess and backgammon.

At the 1988 Summer NABC in Salt Lake City, the tournament directors acquired the late-night habit of congregating at the Howard Johnson's Restaurant after the evening session to enjoy some dessert. Some in the group always ordered banana splits.

For some reason, there had been a delay in the shipment of bananas from South America or Asia and night after night, the TDs were told that there were no bananas.

On the final Sunday of the tournament, Harris approached Gary Blaiss, another national TD. With a grin, Harris said, "I'm ready for tonight." With that, he pulled upon his sport coat and, as a magician would, he produced. . . . a banana.

Chuckling all through the day, Harris was anticipating the familiar refrain at the Howard Johnson's — "Yes, we have no bananas!" He was planning to say, "No problem. Use mine." His plan was to produce the fruit with a flourish from his inside pocket.

The evening arrived. The TDs gathered. The waitress approached. Harris ordered a banana split. Just as he was reaching for the banana, the waitress inquired, "And what kind of toppings would you like, sir?"

The banana supply had arrived and Howard Johnson's, although inadvertently, had foiled Spider's banana split coup.

Harris loved good food, good wine, good company, good music, good literature. Many of his friends considered him an electrical genius – especially when, in the Sixties, he created eight-track tapes from his Beatles albums for them to play on long drives to tournaments.

He was a gourmet cook whose various specialties – from homemade pizza in the late Fifties to bananas Foster that outdid Brennan's best in the Seventies – enthralled his friends.

Harris would never confirm the following story, but it rings true for those who knew him.

In the South, there was a player of particularly obnoxious temperament. In today's Zero Tolerance climate, the player would be thrown out of most tournaments where ZT is taken seriously. Back then, however, things could and often did get out of hand.

At a tournament where Harris was directing, the offending player was so obnoxious to an opponent that a reaction was forthcoming. "You're nothing but a blankety-blank," the opponent finally said in frustrations.

This prompted a call for the director and Harris made his way to the table.

"This man just called me a blankety-blank," the obnoxious one said.

Harris, who always thought fast on his feet, considered his retort for mere seconds before offering a single word in response.

Said Harris, "Sustained!"

Turn 'em off

Cell phones, audible pagers or any similar communication equipment may not be operated or operable in the playing area during a session of play at NABCs except for health-related equipment or by permission of the director-in-charge of the tournament or event.

This is the resolution passed by the ACBL Board of Directors, meeting before the start of the 2000 Summer NABC in Anaheim. While the resolution applies only to NABCs, the board urged that Asponsoring organizations of other ACBL-sanctioned events are strongly encouraged to adopt this policy.

Bid Box Alerts and Announcements

When using bid boxes, ACBL suggests that players tap the Alert strip and say "Alert" at the same time.

When making an announcement, use the announcement word — such as "transfer" — and tap the Alert strip at the same time.

A player who Alerts or announces a bid should make sure his opponents are aware that an Alert or announcement has been made.

USBF Dues

Players are reminded to pay their 2002 United States Bridge Federation dues before the Vanderbilt starts on Sunday.

The \$50 USBF dues must be paid prior to the first session of play in the 2002 Vanderbilt in order for teams to be eligible for Placing Points earned toward a bye in the 2002 United States Bridge Championships.

Look for the "Pay USBF Dues Here" sign and manned desk one hour before game time Sunday at the Vanderbilt playing site at the J W Marriott.

times a week, Leicht said she was so happy to have been selected as Cohen partner's in the drawing that "everyone in San Diego knows I won Larry Cohen."


Regarding their game, which was slightly better than 56%, Leicht said, "It was interesting all the way."


