6 new members for Hall of Fame

The ACBL Hall of Fame will gain six new members at the annual Hall of Fame banquet in Long Beach CA on Thursday, July 17. The inductees will be Jacqui Mitchell, Fred Hamilton, Steve Robinson, Ed Manfield, Tobias Stone and Henry Francis. Following is a brief synopsis of each inductee's accomplishments.

Jacqui Mitchell

Mitchell, a bridge teacher, is a World Women's Grand Master and an ACBL Grand Life Master with nearly 15,000 masterpoints. She has five world championships to her credit – Venice Cup '76, '78, World Olympiad Women's Teams '80, '84, World Women's Pairs '86. She also placed second in the World Mixed Teams in 1974, the World Mixed Pairs, also in 1974, and the Venice Cup in 1985. She has several other high ranking placings in world events.

Her North American championships include the Wagar Women's Teams '65, '70, '74, '75, '76, '83, '87, Women's Swiss Teams '83, '91, Women's BAM Teams '90.

If your partnership plays pre-Alertable Mid-Chart or Super-Chart opening bids or overcalls in events which permit such methods, you must fill out one of the new pre-Alert/Disclosure forms for each such method that you play and make them available to your opponents before the start of each round or match segment.

This applies to any event, NABC+ or regional, which permits Mid-Chart or Super-Chart methods. Look for the light blue forms on the tables where convention cards and pencils are located.

Other experts always play in the seat corresponding to their alphabetical links. For instance, Berry Westra of the Netherlands always sits West (where else?)




Justified confidence

On this deal from the Saturday evening side game, Justine Cushing found herself in a marginal game and threaded her way home with skill.



Cushing, South, was favored with a club lead, but she still had work to do. Perhaps it is right to go to dummy with a top spade – it's far from clear. In practice, she took a heart finesse, and when a club came back she was in deep trouble. Since the club finesse looked odds on to lose, she won her ace, crossed to the ♠K and led a diamond to her jack. When that held she cashed the ♠A, crossed to the ♥A and played a second diamond. This was the position:



East had to take the ◆A and could not keep declarer out of her hand. A diamond return would do no good, and a heart back would allow South to ruff and discard dummy's losing club on the ◆K. Plus 620 was worth 36 out of 38 matchpoints.

Note that if Justine had taken the heart ruff before drawing the second trump, East has a defense. She could win the ◆A and exit with the fourth heart. Declarer must ruff in dummy and has no ready entry to hand, so she must lose a club.

The companion deal also had a lot of interest.

Harvard group invades Philadelphia NABC

The 2003 Spring NABC turned slightly Crimson over the weekend as a contingent from Harvard University made a foray to the biggest tournament they've ever seen.

The group was led by Randi Zuckerberg, who organized a bridge class last year and brought 10 of her students to town to check out the tournament.

Charlotte Blaiss, who runs the Junior program for the ACBL Education Department, said Zuckerberg has done an excellent job getting bridge started again on the Harvard campus.

One of the group, Andy Cotton, said he tried to start a bridge club when he was a freshman but didn't have a lot of luck. Now that he's a senior, he said, a whole new crop of bridge players has sprung up to make a game every Sunday.


Blaiss said Zuckerberg got her class started using the ACBL's School Bridge Lesson Series materials, including free books and lesson plans. Zuckerberg now is eligible to participate in the scholarship program.

At present, Blaiss said, there are bridge clubs at about 20 colleges – and many colleges now are offering bridge classes as credit courses.

"We're trying to get this kind of thing going in all the colleges," she said.

mond lead after I had doubled an artificial diamond call. Justine led a diamond to the ace, and I shifted to the ♥8, which went to the 10 and jack. Justine carefully returned a diamond, and declarer cashed four rounds of spades, ending in dummy. This was the position:



Both defenders had kept all their clubs, so declarer did not know the defenders' shapes. The best line now is to cash the \P A, getting a better count on the North-South hands, then the \P K, forcing a club discard from South, before exiting with the \P Q. In the three-card ending, South will exit innocently with the \P J – and declarer should probably play for split honors and go wrong, winning with the \P K in dummy and finessing against North for the missing club honor.

In fact, declarer tried a slightly different variation – playing South to be 3–5–2–3 and playing three rounds of clubs before cashing the ◆K. Holding declarer to nine tricks for minus 400 was worth a surprising 65% of the matchpoints – virtually no one went down in 4♠. I guess that trump lead was not all that attractive!

Discounted parking

Backwash squeeze

Although it was not the most successful result on his road to victory in the Silodor Open Pairs I, Michael Rosenberg showed me one of the most interesting hands.

Rosenberg and Ralph Katz overreached a couple of tricks when they bid to 4♠. Michael ducked the opening lead of the ♥K but won the second heart. He led a club from dummy to West's king, and West returned a third heart, ruffed. North played a spade to dummy's ace and led a second club. West took the ace and returned a third club to declarer's queen.

Rosenberg crossed to dummy with the \bigstar K and led the last heart. West, still holding the \bigstar Q, \bigstar QJ2 and \bigstar 9, had no answer. If he threw his club he would be put in with the last trump to break diamonds for declarer. If he threw a diamond, that would eliminate the diamond loser. A well-played hand for down one, but what was even more impressive was that Michael recognized the hand type as a *Backwash Squeeze*.

Bob Hamman opened 1NT and Zia bid 2♥ to transfer to 2♠ which became the final contract. The opening lead of the ♠10 was won by Faith Pritchard of Alberta. Trying to keep defensive communications fluid, she switched to a diamond to Hamman's king and her husband Barry's ace. A second diamond was taken by Hamman with the queen and now the stage was set.

Hamman played the ♣A, club ruff and the ♥10 was played from dummy. Had Faith covered this, her goose would have been cooked. A second club ruff, the ◆J and a spade to her king would neatly endplay her. She played low without thought and Hamman gave a little thought to running this before rising with the ♥A and ruffing his last club in dummy. When he played a second heart from dummy West played the queen, and for a second Hamman hoped she would have no more hearts and would have to concede a ruff and discard. When she took the ♣A she triumphantly produced the ♥J to hold Bob to nine tricks.

"These guys are too tough," Bob remarked with a shake of his head and a smile.

The Facts: 3NT made three, +600 for N/S. The opening lead was the \$5. E/W called the Director at the end of the auction and told him that North had misexplained South's double as showing clubs when West asked about the call at his turn immediately after it was made. South had intended his double to show 14+ HCP (N/S's actual agreement).

The Director ruled that North's explanation of the double as showing clubs was unauthorized information to South, who had no reason to bid again over 3♣ (pass was a logical alternative). The contract was changed to 3♣ down one, +100 for E/W.

The Appeal: N/S appealed the Director's ruling and were the only pair to attend the hearing. South explained that he had more than a minimum for his double with fitting club honors, heart stoppers and a good five-card suit.

In addition, he believed that E/W's poor

defense had allowed him to make 3NT. The play had gone: \$\ddots 5\$ to the king; spade to the king; ▲10 to the ace; club to the ace; diamond to the 8, king and ducked; ♥J to the ace; ♣Q (after mumbling "Oh well"); ♦J ducked all around; heart to declarer's hand, which was good. South also admitted that North's 3. bid was non-forcing.

The Committee Decision: The Committee believed that South's hand

was a clear minimum for his double which, together with his admission that 3. was non-forcing, clearly made a pass of 3. a logical alternative. As for E/W's defense of 3NT, while might be considered somewhat careless, the Committee did not believe it to be "egregious."

The contract was therefore changed to 3. by North. In evaluating the possible results in 3.4 the Committee judged that after the likely heart lead (the suit West bid in response to Stayman) to the ace and a shift to the ◆J, ducked by East, the contract would easily end up down two. Therefore, the score for 3.4 down two, +200 for E/W, was assigned to both sides.

Finally, the Committee believed that N/S had failed to present any credible evidence to support their contention that South should be allowed to bid 3NT. Therefore this appeal was judged to lack substantial merit and N/S were each assessed an Appeal Without Merit Warning.

The Facts: $3 \checkmark$ went down one, +100 for E/W. The opening lead was the 4. E/W called the Director immediately after South took some time to double 2. N/S agreed that South took 4-5 seconds before doubling. E/W believed that South had broken tempo before doubling (5-7 seconds) and that North should not be allowed to pull the slow dou-

The Director ruled that passing 2 doubled was not a logical alternative for North (Law 16A) and allowed the table result to stand.

The Appeal: E/W appealed the Director's rul-

ing. E/W said that South took 5-7 seconds before doubling 2. They believed this constituted a break in tempo and that North should not be allowed to pull the double since, in their opinion, pass was a logical alternative.

N/S said that South's failure to bid 1♠ over 1♥ denied four spades and with almost nothing to contribute to the defense North could

not visualize a hand for South that would produce six defensive tricks opposite his hand.

The Committee Decision: The Committee believed that the statements by both sides that South took 4-7 seconds to double 2♠ constituted an agreement that there had been a break in tempo. They then turned to the logical alternative issue. The Committee agreed with the Directors that passing 2♠ doubled was not a logical alternative for North and allowed the table result to stand. (They also noted that E/W might easily have defeated 3♥ by two tricks rather than just one.)

Concurring Opinion (Jeff Polisner): While I agree that passing 2 doubled was not a logical alternative for North, I disagree with the judgment that the 5-7 second pause before South doubled 2.

was out of tempo under the circum-

In fact, a faster double would have been out of tempo "the other way," making it impossible to allow North to pass. A player must be permitted (even required) to consider his calls briefly

before acting (especially when doubling in a position such as the one South was in here) and the 5-7 seconds South took were entirely appropriate within that context.

Charles Goren and Harry Fishbein traveled to a tournament in upstate New York. Each was playing with a different partner.


Goren won five events with his partner. Fishbein was second in each of the contests won by Goren.

Vanderbilt packed with fine teams

With so many good teams in the mix, it's hard to pick a favorite in this year's Vanderbilt.

Borrowing the NCAA basketball format, these might be the top seeds in each region:

- The reigning Bermuda Bowl champions: Rose Meltzer-Kyle Larsen, Peter Weichsel-Alan Sontag, Chip Martel-Lew Stansby;
- The former (and, most likely, future) Bermuda Bowl champions: Nick Nickell-Richard Freeman, Jeff Meckstroth-Eric Rodwell, Bob Hamman-Paul Soloway;
- George Jacobs & Company (Ralph Katz, Alfredo Versace-Lorenzo Lauria, Norberto Bocchi-Giorigo Duboin);
- The defending Vanderbilt champions: Reese Milner, Marc Jacobus, Sam Lev, John Mohan, Jacek Pszczola and Piotr Gawrys.

The Vanderbilt Trophy

The Vanderbilt Trophy was donated in 1928 by Harold S. Vanderbilt, who won the event in 1932 and 1940.

The Vanderbilt was contested annually in New York — as a separate championship — until 1958 when it became part of the Spring North American Championships.

Vanderbilt winners receive replicas of the trophy — a practice initiated by Vanderbilt from the first running of the event and perpetuated by a \$100,000 trust fund administered by ACBL under the terms of Vanderbilt's will.

On display at ACBL Headquarters in Memphis are replicas donated by the families of Caroline Taylor, who won the Vanderbilt in 1928, and Helen Sobel Smith, a Vanderbilt winner in 1944 and 1945.

overcalled, and LHO raised his partner. RHO went back to his suit and Allen bid again. LHO bid again, as did RHO. Allen was not to be denied, but when she bid a third time, LHO doubled and Allen went down.

While her partner glared at her, Allen noted that someone approached her right-hand opponent and commented on a book he had written. Turning to LHO, Allen asked, "Who is your partner?"

"That's Alfred Sheinwold," said the younger man

"If I had known," said Allen, "I wouldn't have bid so much. So who are you?"

"I'm Frank Stewart."

Ruby, 75, was born in New York but has lived in Massachusetts since she was five. She now lives in Chestnut Hill. Allen, 77, lives in Brookline.

Both learned bridge at home as youngsters, although they didn't take up duplicate until later in life.

Allen trained in medical research and worked as a medical technician, doing research on malaria, diabetes and hypertension, among other maladies. She is proud of the fact that she published several medical papers.

Ruby and her husband, who died five years ago, operated a business making zippers.

Allen and Ruby met at the Jewish Community Center in Boston years ago but didn't play together much until Ruby's husband, Abbott, died. Allen had a brief marriage a long time ago that produced one daughter. Allen and Ruby are now free to travel and play bridge wherever it suits them.

"Bridge has filled a void in my life," says Ruby. Both have many fond memories from the game.

Allen recalls that in 1981, she was close to making Life Master, and she wanted to have just enough masterpoints before the 1981 Summer NABC in Boston so that she could earn her gold card in her home town. She went to regionals in Las Vegas and Lancaster PA, and everything worked out just right. She made LM at the Boston NABC.

Even better, on the day she had made it, Allen and her mother got on an elevator at the hotel with Charles Coon, one of the all-time great players of New England. Said Coon to Allen's mother: "Mrs. Fox, isn't it great about Adacie."

Recalls Allen: "I was thrilled."

The two women are competitive but not concerned if their results aren't the best. Not that they don't like to win – they were thrilled at last year's Spring NABC in Houston to take home more than 30 masterpoints each. Still, it's the social aspect of the game that keeps them coming back, plus the opportunities for travel. Both are blessed with good health and a lust for life.

Says Ruby: "Bridge is our way of seeing the U.S."

They like tournaments in Canada, too. "We went to Vancouver (for the 1999 Spring NABC) and played a lot of bridge, but we did a lot of touring, too. We walked all over Vancouver."

Fred Hamilton

Hamilton, a professional bridge player and teacher, is a World Grand Master and an. ACBL Grand Life Master with nearly 29,000 masterpoints, the eighth best record in the ACBL. He was a member of the American team that finally broke the Italians' hold on world championships when the Americans won the Bermuda Bowl in Monte Carlo in 1976.

He also won the World Senior Pairs in 1994 and the World Transnational Senior Pairs in 2000. He was second in the Bermuda Bowl in 1977, the World Team Olympiad in 1980 and the World Senior Teams in 1994. He has had other high finishes in world events.

He is the inventor of the convention known as Hamilton, a method of defensive bidding against an opening notrump.

He won the Reisinger '74, '75, '78, '79, Vanderbilt '77 and Spingold '79. Other NABC victories: Mixed BAM Teams '76, Grand National Teams '98. Senior KO Teams '96, '98, Senior Swiss Teams '98, Silver Ribbon Pairs '01, IMP Pairs '89, Lou Herman Trophy '74.

Ed Manfield

Manfield, who was an economist and an options trader, was a World Life Master and an ACBL Grand Life Master with more than 11,000 masterpoints.. He was the author of two influential series of articles in *The Bridge World*. The first, *The Philosophy of American Slam Bidding*, dealt with the importance of establishing a fit early in slam auctions. The second, *High-Level Bridge*, dealt with competitive bidding, in which he proposed the use of fit-showing jumps. He won International Bridge Press Association award for best article in 1982-83 for *I've Got A Secret*, and he shared the award in 1979-80 for *High Level Bridge*. He also won an award in 1987 for *The Five Level Belongs to the Opponents*.

He won the World Rosenblum Teams in 1986 and placed second in the same event in 1982., His North American championships included the Vanderbilt '91, Blue Ribbon Pairs '86, '87, '90. Spingold '79, '81, Reisinger '80, Men's Pairs '85, Open Pairs '87, '89, Men's BAM Teams '86, '89, Open BAM Teams '94, Grand National Teams '84, '88, '92.

He was victorious in the Cavendish Invitational Pairs 1979. He also won the Lou Herman Trophy in 1986 and the Bols Brilliancy Prize for best defended hand in 1982.

Steve Robinson

Robinson, a retired computer specialist who is now a bridge professional, is a World Life Master and an ACBL Grand Life Master with about 28,000 masterpoints, ninth in the ACBL.

He was victorious in the Rosenblum Teams in 1986, the World Mixed Teams in 1974, the World Senior Teams in 2000 and the World IMP Pairs in 1901.

His long list of North American triumphs includes the Vanderbilt '87, '91, '97, Reisinger '72, '86, Blue Ribbon Pairs '73, '75. Men's Swiss Teams '86, Men's BAM Teams '78, '89, Open BAM Teams '94, Grand National Teams '84, '88, '92, Men's Pairs '72, Mixed Pairs '85, North American Pairs '85. He won the Lou Herman Trophy in 1972 and the Mott-Smith Trophy in 1987

He is the author of *Washington Standard* and the inventor of the CRASH convention. He has been very active in the Washington Bridge League since 1971 and in District 6 since 1975

Tobias Stone

Stone, bridge author, is a World Life Master and an ACBL Diamond Life Master. Co-inventor of the Roth-Stone System, he has made many contributions to bidding theory. He is co-author of *Bridge is a Partnership Game* and *The What Do You Play and Why* feature of *The Bridge World*. He and partner Al Roth were the first Americans to win the

Starting times – 10 a.m. or 1 p.m.?

Which do you prefer – two-session events that start at 10 a.m. or those that start at 1 p.m.? The special survey conducted at the Phoenix NABC last fall found the vote split almost down the middle, with a small majority favoring the afternoon.

For regionally rated events, the vote was 388-367. The vote for the afternoon was more pronounced when it came to national events – 426-337. However, the intermediates and newcomers had a slight preference for the morning, 132-122.

The schedule at Phoenix was different – it started on Thanksgiving Day instead of having the holiday fall in the middle of the tournament. How did the players feel about that? Officials were a bit surprised to learn that the vote for Thanksgiving as the opening day got more than twice as many votes, 244-115. However, another 178 players would like the Fall NABC take place earlier in November, even though room rates would be quite a bit higher. 313 players said the dates would have no effect on their decision to attend or not attend.

The survey also focused on Zero Tolerance – is this policy being enforced to the players' satisfaction? The vote was an overwhelming "Yes," 530-122.

The Daily Bulletin got high marks in the survey. 459 players said they like the feature stories about people and events. The published hands got 445 votes. Section results take up a lot of space, but it's clear the players want them – 407 votes. Forty-two other players also had suggestions on new ideas for the Daily Bulletin.

He won several bridge-writing prizes for articles in *The Bridge Bulletin* and World Championships Daily Bulletins. A Gold Life Master, he has many regional wins to his credit.


Thursday night in the ACBL Educational Foundation Stratified Open Pairs. Munoz is the Patron Member who won the drawing to play with Cohen.

When Munoz first met Cohen, Munoz was in the banking business, which didn't leave him a lot of time for tournament bridge. Now that he's retired, Munoz makes all the NABCs each year as well as a few regionals. He regularly plays with two of New York's finest – Allen Stauber and Warren Rosner.

Munoz and Cohen finished Thursday night with a 179.5, good for third place. "We weren't dealt enough to win the event," says Munoz, "but we could have won the section but for a couple of bad boards."

Munoz and Cohen played a fairly sophisticated card and, according to Munoz, they clicked on defense right away.

On the following deal, Cohen made the most of a good bid by Munoz to land a doubled contract for a top.



East's double was a dubious action, considering that his club honors were likely to be in front of the opposing high clubs rather than behind them.

At any rate, Cohen ruffed the opening high heart lead with the \bullet K, following with a diamond to his hand and a low club toward dummy. East ducked, the \bullet K won in dummy and Cohen entered his hand again in trumps. When he led another club, East played the ace. From there, Cohen was able to ruff a club, eventually losing only one spade trick and the \bullet A for plus 750.

Although they didn't do as well as Munoz had hoped, he knew going in that he would have a good time with one of ACBL's best players – and he was right. Says Munoz: "It was fun."

No wonder he had a squeeze!

Director Olin Hubert discovered that George Jacobs still had four cards while everyone else at the table had only three.

Jacobs knew he had a double squeeze because he had determined the RHO had clubs and LHO had spades, and that's what he told the director. "I've got the rest of the tricks anyway," he said.

"Of course you do," said Hubert. "You have more cards than they do."

On one round from the second final session of the North American Pairs, Flight A, the winners, Steve Landen and Michael Zerbini, found themselves in that position twice. They survived the tightrope walk to win the event. This was the first board.

3NT is clearly a better contract than 4, considering the mirror distribution and lack of ruffing possibilities. Declarer could lose a spade trick and still make his notrump game, whereas losing a trump trick in a spade game would likely result in a minus for North-South.

Zerbini made the normal lead of a club, taken in dummy with the queen. When declarer called for a spade, Landen put up the king. Declarer apparently took the AK as a true card, winning the ace and playing the AQ and another spade, expecting East to win, which would prevent him from playing another club to good effect.

Imagine declarer's surprise when Landen won the ♣J. Landen returned a club, establishing Zerbini's suit while he still had the ♥A as an entry. Declarer took only eight tricks to finish down one.

The next board was even more dicey for the winners.

There's only one lead to defeat the diamond partial – a club. Even with a trump lead, declarer can win, overtake the $\triangle Q$ to pitch two clubs and a heart, then arrange to ruff one heart in dummy and two clubs in hand. He makes plus 670 with the trump ace, the $\blacktriangledown A$, a heart ruff, four spades and two club ruffs.

On a club lead, East can win the ace and continue the suit or switch to a trump. Either way, declarer comes up a trick short. On a trump switch, declarer can win the ace, take a club pitch when he runs dummy's spade winners, but when he plays a third round of clubs, East can ruff in with the ◆10, and declarer would take no more tricks.

Landen led the $\bigstar K$, but declarer mistimed the play to finish down one for minus 200 and another top for the winners.

Black queen jettisons

Playing against world champions brought out world class defense from the new partnership of Bharat Rao and Burrel Humphreys. In the first match of a four-way in yesterday's Vanderbilt, Rao and Humphreys had the (mis)fortune to draw Giorgio Duboin and Norberto Bocchi of Italy, the current Rosenblum world champions.

A little backdrop: Rao had declared four or five hands against Duboin and Bocchi and each time one of them was on lead Rao thought to himself, "Gee, I hope they don't switch to this suit." And they would. Or, "Gee I hope they don't play that card." And they would. So, after the first 12 hands that old numbing feeling was sinking in, as in "these guys are way way too good." Then came this hand:

Humphreys passed as dealer, Duboin opened $1 \, \Psi$, Rao passed and Bocchi bid 1NT showing at least five spades. Duboin responded $2 \, \Phi$ which denied as many as three spades Bocchi rebid $4 \, \Psi$, ending the auction.

Rao led the \$5. Duboin hopped up with the king in dummy to play a diamond to his ace and ruff a diamond in dummy. He returned to hand with the \$A and ruffed another diamond with the 4. Now Duboin cashed the \$A\$ and Rao casually dropped his queen(!) Taking this at face value, Duboin called for the \$9 from dummy, and now it was Humphreys' turn — he played his black queen(!).

Duboin ruffed with the 3 and played the ◆Q, covered by the king, ruffed with the 9 and overruffed with the 10. Humphreys now played the ♣10 and the look on Duboin's face was well worth the price of admission, (even if I didn't pay a cent.)

Duboin shrugged and then ruffed the club with the 8 as Rao pitched the ♠5. Next came the ♥K. Rao won his ace and got out a diamond and claimed the last two hearts, his queen-7 sitting over declarer's jack-6.

Note that declarer is always cold for his contract by ruffing two diamonds in dummy and pitching another on the AJ, the classic loser-on-loser play. Then it is just a matter of powering out the trumps. However, by jettisoning his AQ, Rao painted a different picture of the defensive layout. By throwing his AQ Humphrey's perpetuated the forgery. Well done, gentlemen. World class defense against a world class declarer.

Slow play is our game's curse

Patty Johnson, Sebring FL, is a National Tournament Director and the Director-in-Charge for all District 9 (Florida) tournaments. She is in charge of tournament operations at NABCs.

An old tournament director friend of mine, John "Spider" Harris, was famous for the saying: "Slow play is the curse of the game." Nothing is more frustrating for tournament directors than having to herd players along like cattle when slow play isn't actually the problem.

If you take a moment to think about it, most of your opponents do not take that long to bid or play a deal — yet before you know it, the round is being called and you are nowhere near finished with the last board.

Here are some suggestions which, if followed, would solve many of our problems.

First: do not post mortem between deals whether you are in a pair game or a Swiss team event. Finish the round and then discuss hands if there is still time. We, as directors, will not cut your time, but I think you will find yourselves under less pressure by following this suggestion. Remember: we provide hand records in pair games so you don't have to worry about forgetting a particular holding.

Second: if you are on opening lead, make your lead before recording the contract in your private score. You will have plenty of time after leading to record the information and still see the entire first trick.

Third: unless you have a legitimate reason to leave the table, such as the restroom or a smoke break, please remain at the table and visit with your opponents. You might actually find this enjoyable and a new way to make friends or future Swiss team partnerships.

I wish we could make these suggestions into rules enforceable by penalty, but none of us wants a bridge event decided by the pair with the fewest penalties. All I can do as a director is ask the cooperation and help of all players. I think not only you but everyone else will enjoy their tournaments more.

Remember: those who enjoy a tournament will continue to play. Do your part to make bridge enjoyable for yourself, your partner and your opponents — you can't play without them.

"I usually don't open 24 when I have a twosuiter," said Albert, "but this time I started with the two-bid. Marilyn's 3♥ bid promised at least a singleton or an ace or a king. I made a series of cuebids. When Marilyn kept returning to hearts, I knew she had the **\(\Lambda \)** K but nothing else of value."

Getting to the heart slam was worth 32 of a possible 38 matchpoints, but Albert found a way to take all 13 tricks and gain 37.5 matchpoints.

He won the opening heart lead with dummy's 10 and took an immediate diamond finesse. He cashed the top heart and the A and crossed to the ♠K. When the jack fell, he cashed the ♠10, led a diamond to his ace, cashed the \(\text{Q} \) (pitching a diamond from dummy) and ruffed his last diamond.

The Silver Ribbon Pairs has been won by four members of the ACBL Board of Directors: Joan Remey Moore, District 12 director, playing with Helen Shanbrom in 1993; Virgil Anderson, District 15 director, playing with Jayne Thomas, District 9 director, in 1994; and Jim Kirkham, District 22 director, playing with his wife Corinne in 1999. (Anderson was ACBL president at the time and the only "sitting" president to win an NABC event.)

The winners will have their names inscribed on the Leventritt Trophy and will receive a certificate of recognition.

The trophy honors Peter Leventritt of New York, ACBL president in 1954 and assistant treasurer 1945-46. He served as president of the Greater New York Bridge Association and the Card School of New York, which he co-founded.

Leventritt (1916-1997) pioneered the use of the Schenken System in partnership with its inventor, Howard Schenken. He represented North America in the Bermuda Bowl and placed second in 1957, 1961, 1963 and 1965.



A fun yarborough

Sometimes a varborough can be fun. You probably think "not again!" when you pick up the South cards, but your interest perks up when you hear the bidding.



After West opens, partner doubles and East leaps to 3. With zero points certainly pass is an option – but you have six spades! If partner has as little as the A-K fourth, a doubleton diamond and an outside ace, you have a good save against a club game. So you put it to the opponents immediately – you bid 4♠.

It turns out that partner has the best hand at the table. You win the opening club lead and play a top trump. When East shows out, you get to your hand by ruffing a club and take the marked trump finesse. After drawing West's last trump, you work on hearts. When the 10 drops doubleton, you go down only one – two hearts and two diamonds to

As you can see, the opponents are cold for a club game, but it's hard for West to go to five after partner's preemptive raise. Perhaps East should have given more weight to his spade void – but he didn't. You stole the contract with your jump bid on a yarborough.

Convention cards—it takes two!

Each player is required to have a convention card filled out legibly and on the table throughout a session. Both cards of a partnership must be identical and include the first and last names of each member of the partnership.

If a director determines that neither player has a substantially completed card, the partnership may play only Class A conventions and may use only standard carding. This restriction may be lifted only at the beginning of a subsequent round after convention cards have been properly prepared and approved by the director. Further, the partnership will receive a 1/6 board matchpoint penalty for each board played, commencing with the next round and continuing until the restriction is lifted. In IMP team games, penalties shall be at the discretion of the director.

If the director determines the partnership has at least one substantially completed convention card but has not fully complied with ACBL regulations, the director may give warnings or assign such penalties as he deems to be appropriate under the circumstances.

The objective of these warnings and penalties is the encouragement of full compliance with ACBL regulations.
